2017 APPA Conference Is Major Success



With a combined community of APPA's institutional delegates, special guests, and supporting business partners, the 2017 APPA/PCAPPA/BayAPPA joint annual meeting and exhibition at the Hilton San Francisco Union Square Hotel from July 21–23 was an overwhelming success that brought together more than 800 attendees to listen, learn, and network together over four information- and resource-packed days. A highlight of the conference was outgoing president **Chuck Scott** passing the gavel to **Christopher M. (Chris) Kopach**, assistant vice president for facilities management at the University of Arizona, as APPA's new president.



Kopach (right) has been a long-serving member of the RMA board in various positions, including host committee chair, awards & recognition chair, president-elect, president, junior representative to APPA, and senior representative to APPA. He also responded to a desire for webinars among RMA members and volunteered to continue to serve as host for these events.

When APPA put out a call for editors for the Body of Knowledge (BOK), Kopach was one of the first to step up for this assignment and currently serves as content coordinator for the operations and maintenance section. He also chairs the University of Arizona Amigo Group, which fosters relationships between RMA, APPA, and institutions in Mexico.

Kopach has won numerous awards for his work and contributions, including the RMA President's Award, Val Peterson Award, and APPA Pacesetter Award. He was an APPA Thought Leaders Symposium presenter in 2014, on "Leveraging Facilities for Institutional Success," and served on an APPA Regional Relationship Task Force.

Under his leadership, the University of Arizona received the APPA Award for Excellence in 2013. Kopach has led the way for RMA and all APPA institutions with his support of the APPA Leadership Academy, bringing the Academy on Campus tracks to Arizona, and creating an apprenticeship program for the facilities management department to address long-term succession planning in the trades. He is also a strong supporter of both the EFP and CEFP.

Kopach's theme for his presidential term is "Harnessing the Knowledge and Transferring this Knowledge to our Current and Future Leaders."

"Since 2002, APPA has played a critical role in my professional development as I have advanced in leadership positions," Kopach said. "I want to give back to APPA members."

APPA Supports Efforts in Tax Reform Opportunity

APPA leaders recently wrote to Senator Orrin Hatch and members of the Senate Committee on Finance in response to a recent invitation for tax reform recommendations that would grow the U.S. economy and create jobs. The letter said urged the committee to consider reforms to Section 179D as a way to boost economic fundamentals: "... the Section 179D tax deduction for energy-efficient commercial and larger multifamily buildings has leveraged billions of dollars in private capital, resulted in energy-efficient enhancements to thousands of buildings, and created and preserved hundreds of thousands of jobs since its inception."

The letter provided the executive summary of a recent economic impact study by Regional Economic Models, Inc. (REMI) to highlight REMI's "unequivocal" conclusion that "Section 179D is an engine of economic and employment growth" and that "an enhanced tax incentive for energy-efficient commercial buildings, including reforms geared toward retrofits of privately-owned buildings, could support up to 76,529 jobs and contribute almost \$7.4 billion toward our national GDP each year. These results represent a significant return on the taxpayer investment in Section 179D, well in excess of the provision's revenue cost."

The study also confirms that "extending the current version of Section 179D or making more modest changes to the incentive would have a substantial positive impact on economic and employment growth."



Certified? It's Always a Good Time to Recertify



More than 1,000 APPA members have achieved the EFP or CEFP credentials since the EFP rollout in 2007 and CEFP rollout in 2009. If you have already reached this valuable professional milestone, it might be time to get recertified. This must be done every four years, but you don't have to wait that long – recertifying is a great way to refresh and enhance your current knowledge.


