#### U Texas at Austin Wins Award for Innovative Irrigation Program

An irrigation system at the University of Texas at Austin has won the Texas Environmental Excellence Award for Water Conservation from the Texas Commission on Environmental Quality. The system was developed



by **Markus Hogue**, program coordinator for irrigation and water conservation and a licensed irrigator for the campus.

An audit revealed that the university's irrigation system could not monitor and adjust water use during irrigation and in times of drought. Hogue spent the last six years redesigning and updating the university's central irrigation system. The new system includes a live weather feed, evapotranspiration data mechanisms, rain buckets, low precipitation nozzles, flow monitoring with the ability to regulate irrigation schedules, and detection that automatically shuts down leaks in the system.

The new irrigation system also collects and stores water data. Faculty and students have access to the data, which is incorporated into university courses and student research. The system has resulted in a 66 percent drop in water use over the last six years, which saves more than 100 million of gallons per year and eases demand for water use on landscaping, even during recent drought conditions.

An online irrigation dashboard helped the school win the award. Hogue has figured out a way to visualize the irrigation usage on campus and publish the data online on an interactive map. He presented a podcast about it with the EPA and Alliance for Water Efficiency a few months ago.

#### Madison College Plans Major Solar Installation



Madison Area Technical College in Madison, WI, will add \$1.8 million to a grant from Madison Gas and Electric (MGE) to build a 1,400 kilowatt solar photovoltaic (PV) system on top of its main Truax Campus building. The system will be accessible to students; serve as a demonstration of new, clean energy technology in the community; and could save the campus more than \$200,000 per year in electricity costs.

"Our system will be the largest rooftop PV system in Wisconsin," said **Ken Walz**, chemistry and engineering instructor and director of the Center for Renewable Energy Advanced Technological Education. "On a sunny day, the system will reduce the college's peak electric load by about 50 percent. Averaged over an entire year, it will offset about 10 to 15 percent of the college's total electric consumption."

Madison College is one of three colleges behind the Center for Renewable Energy Advanced Technological Education (CREATE), which works to advance renewable energy education by supporting two-year college renewable energy programs.

## Northwestern Applies "Simple Fix" to Saving Energy



With a simple fix, **Northwestern University** has achieved a 90 percent reduction in wasted energy since 2013, amounting to savings of nearly \$2 million per year. The secret? Fixing leaky steam traps.

Steam traps are automatic valves that filter out condensate collected in pipes. The condensate is then recycled back to a boiler to be converted into high-pressure steam that shoots through an elaborate labyrinth of pipes to deliver energy to more than 200 buildings on the Evanston, IL, campus.

**Dave Vandas**, chief maintenance engineer for Northwestern University Facilities Management, and his team assessed the state of the university's 1,851 steam trap valves and reduced the failure rate of those traps from 23 percent to just 4 percent over the past four years. Every year, NUFM staff spend eight hours per day for three weeks straight on inspecting all 1,851 steam traps.

## Expanded FPI Report Now Available for Survey Participants and Interested Colleagues

APPA's 2015–16 expanded Web-based **Facilities Performance Indicators (FPI)** report is now available for both survey participants and non-participants to purchase. The FPI report empowers educational facilities professionals with the vital data, statistical references, and reporting tools they need to measure operations and performance, identify capital asset realities, and lead a successful facilities strategy that supports an institution's mission and vision.

The FPI report can help you make the business case for your facilities needs; address capital asset realities; create a balanced performance score card based on critical data findings; and

This is the only report readily available on the costs and practices of facilities operations at educational institutions. Based on an annual survey of colleges, universities, K-12 organizations, and other educational entities, the FPI report includes data from nearly 300 institutions allowing extensive comparisons of average costs for different types of space and institutions such as staffing levels, salaries, and performance levels for custodial, grounds, maintenance, and other functional areas.

The report is free to APPA member survey participants; \$500 for APPA member/non-survey participants; and \$895 for APPA nonmember/survey participants.

## USGBC Makes Statement on Withdrawal of the U.S. from the Paris Agreement



The U.S. Green Building Council (USGBC) has issued a statement in response to the withdrawal of the U.S. from the Paris Agreement on climate change: "We implore you to stay strong and focused and to keep building. And remember: we stand with you, and we are all in. Let's continue to LEED on."

The statement also says: "... the Paris Agreement, under the UN Framework Convention on Climate Change (UNFCCC), establishes voluntary actions to address greenhouse gas emissions and global climate change mitigation and adaptation—and 194 countries

around the world are signatories .... We are deeply disappointed to learn of the administration's

decision to withdraw from the historic Paris Agreement ... we have reached the point where the transition to a low-carbon economy is inevitable, but making the transition remains urgent."
