The APPA 1000 TCO Standard is out for public comment, and anyone interested in reviewing the document must get their comments in to Billie Zidek, APPA's standards and codes administrator, at billie@appa.org, by 5:00 p.m. Eastern time on September 19, 2017. This is your chance to have a voice in the making and value of an important standard for facilities management.

You can also enhance your understanding of this important standard by attending a webinar on APPA 1000: Total Cost of Ownership (TCO) for Facilities Asset Management to be offered by the Total Cost of Ownership (TCO) Work Group, under the auspices of the APPA Standards and Codes Council (ASCC), from 12 noon-1 p.m. Eastern on Wednesday, August 16.

The goal of the webinar is to help move the industry focus from a first-cost view of assets to a moresustainable model that will profoundly benefit owners and facility managers in ensuring that facilities remain vital assets to any organization.

The webinar will provide insights into how the standard was written to establish a common framework for owners of facilities assets to use in identifying and more effectively tracking and managing costs of a facility, building, or supporting infrastructure or assets over the full life cycle based on TCO principles. The common framework would forecast investment needs and simplify data decision

ERAPPA to Offer Lunch and Learn Webinar on Integrated Pest Management



The next Lunch and Learn Webinar from ERAPPA, coming up from 12 noon-1 p.m. Eastern on Thursday, August 17, will focus on "Institutionalizing Integrated Pest Management," presented by Veronika Carella, legislative director of the Maryland Children's Environmental Health Coalition (www.mdcehc.org). This session is designed to empower facility managers to address environmental risks as opportunities to improve environmental health and well-being throughout their institutions. It will highlight the issues that arise when "green" construction supersedes "healthy" construction.

By institutionalizing Integrated Pest Management (IPM) in building design, construction, renovation, maintenance, operations, custodial activities, and grounds maintenance, as well as embedding the principles of green cleaning, facilities managers will not only improve IAQ/IEQ and increase building efficiency, they will also contribute significantly to the overall experiences of students, staff, and users of their facility.

CAMPUS NEWS

UMass Amherst, Eversource Renew Energy-Efficiency Partnership

The University of Massachusetts Amherst and Eversource have signed a three-year memorandum of understanding to continue their energy-efficiency partnership, with the goal of saving the university \$1.8 million in energy costs annually. The partnership has contributed to reducing electrical consumption on campus and supports the UMass Amherst commitment to sustainability, reduced carbon emissions, and responsible use of energy.

They are working on improvements across campus, such as additional LED upgrades, enhancements to HVAC systems, and the continuation of the Green Labs initiative, which targets research labs to reduce ventilation airflow and energy usage while improving safety. New projects are expected to deliver year-after-year energy and cost savings, and reduce CO2 emissions by more than 4,800 metric tons.



Northwestern University Benefits from Using LED Bulbs

In December 2016, Northwestern University began replacing all of its exterior lights with LED bulbs. This first phase of a larger project is scheduled to be completed in September. Phase 2 will be a two-year effort to replace all old exterior lighting on existing buildings. As a result, NU's outdoor lights



consume 50 percent less energy, with additional savings from converting metal halide lights to LEDs. On completion of phase 2, the university will save more than 3000,000 KwH and \$40,000 per year. A control system dashboard that alerts the chief engineer when a light burns out, boosting both productivity and morale.

Certified? It's Always a Good Time to Recertify



More than 1,000 APPA members have achieved the EFP or CEFP credentials since the EFP rollout in 2007 and CEFP rollout in 2009. If you have already reached this valuable professional milestone, it might be time to get recertified. This must be done every four years, but you don't have to wait that long – recertifying is a great way to refresh and enhance your current knowledge.

NCS Webinar Looks at BIM Implementation

Many design professionals in the U.S. building industry still require and rely on computer-aided design (CAD)-based, two-dimensional drawings for project information delivery. In 2014, the developers of the United States National CAD Standard® (NCS)—the American Institute of Architects (AIA), Construction Specifications Institute (CSI), and National Institute of Building Sciences (NIBS)—released NCS Version 6 (V6), which includes a new section on implementing



BIM. A new webinar, "BIM Implementation," to be held from 2-3 p.m. Eastern on Thursday, August 17, 2017, will highlight this new content.

The NCS Steering Committee added a new BIM Implementation Section to the NCS V6 to clarify applicability of NCS content and provide new basic BIM guidelines. Johnny Fortune will help attendees understand why the Steering Committee added BIM information to the NCS V6, identify what NCS content applies to implementing BIM, clarify which BIM guidelines are typical, and explain how to implement the NCS V6 BIM content.

Customized Solutions Reduce Negative Impact of Light on Sleep

A new study that purports to "end the debate over blue light's negative impact on ... health and sleep" may be of interest for colleagues responsible for lighting in dorms.

"The effects of spectral tuning of evening ambient light on melatonin suppression, alertness and sleep," published in the journal *Physiology and Behavior*, was conducted by the Division of Sleep and Circadian Disorders at Women's Hospital, a teaching affiliate of Harvard Medical School, with lighting technology provided by Rhode Island-based Lighting Science.

The study provides scientific evidence that selectively reducing the amount of short-wavelength (blue) light emitted by a light reduces the "alerting effects" of typical indoor bedroom intensities before bedtime. C-LED lighting had multiple benefits compared to typical fluorescent light. The study shows that designing lighting to selectively inhibit the right wavelengths can substantially reduce the circadian disruption caused by exposure to light before going to bed. In designing light systems, completely filtering all short wavelengths can cause color distortion and may render the lighting impractical.
