ASHRAE Survey, December 10 Deadline



As part of APPA's close relationship with ASHRAE, we are urging APPA members to participate in an ASHRAE research project titled **ASHRAE RP-1650: Training Requirements for Sustainable, High-Performance Building Operations**. According to researcher Jaya Mukhopadhyay, assistant professor of architecture at Montana State University, "The aim of this survey is to gain an insight into the knowledge and skill requirements of the O&M staff to operate high performance building systems and equipment. The results of the survey will help us formulate training documents that address knowledge and skill sets that are required for O&M personnel to effectively operate such high performance building systems and equipment." The survey deadline is Sunday, December 10, so please complete the survey as soon as possible. We'll share the results when the project is completed.
