

San Mateo County Community College District Partners with Global Energy Management Specialist on Comprehensive Energy Efficiency Initiative

A global specialist in energy management and automation has announced an energy efficiency project with the San Mateo County Community College District (SMCCCD). When completed, the project will improve energy and operational efficiency across three district campuses through the installation of utility metering technology, new user interfaces for building and utility management, and advanced system analytics. The upgrades are designed to create a cohesive facility management system that will help increase efficiency, improve maintenance and operations capabilities, and ensure 82 buildings throughout the district support student learning while reducing energy waste. SMCCCD is the first community college in California to bring building control, energy management, and building analytics onto one platform, allowing facility managers to visualize, analyze, and realize significant energy savings. Once completed later this year, the district will have the ability to continually monitor and improve its energy performance from a single interface while achieving its broader education goals. Solar Decathlon 2015: Nation's Leading Sustainable Home Design Competition on the Horizon

The U.S. Department of Energy Solar Decathlon — America's premier collegiate competition that challenges students from around the world to design, build, and operate highly energy-efficient, solar-powered houses — will open October 8 in Irvine, California. Sixteen collegiate teams involving more than 2,000 students from 27 schools are deep into construction, assembling their

innovative houses on or near their campuses. In less than three months, the students will transport and open those houses to the public in the Solar Decathlon village, where they'll demonstrate just how affordable, attractive, and comfortable these zero-energy homes have become — homes that are so efficient that a solar energy system can offset all or most of their energy consumption. The collegiate teams will arrive at the Solar

FEDERAL GREEN BUILDING Federal Efforts and Third-Party Certification Help Agencies Implement Key Requirements, but Challenges Remain

As the U.S.'s largest energy consumer, the federal government spent about \$7 billion in fiscal year 2014 to provide energy to over 275,000 federally owned or leased buildings. Federal law and policies for improving sustainability across the federal government include "green building" provisions — construction and maintenance practices designed to make efficient use of resources and reduce environmental impacts, among other benefits. Third-party certification systems are used to assess how well green building elements are incorporated into a building's design and operation. GAO was asked to review federal green building efforts and agencies' use of third-party certification systems. This new report provides an update on these efforts. It examine 1) federal efforts to support agencies' implementation of key green building requirements, 2) select agencies' use of third-party certification systems, and 3) challenges select agencies face in implementing requirements.
